






The 2nd International Scientific Conference for Persons with Disability in Times of War

Conference Idea:

A significant percentage of persons with disability is found among the Syrian society. This is due to the war still on the wage for 12 years. The absence of accurate data base of this category is obvious. Yet, the UN report of 2021 about Syria implies that:

severely disable, their number is 146.486 individuals.

According to the UN Convention of Rights of the persons with disability issued in 2006, the concept "persons with disability" includes all those suffering from long term physical, mental, intellectual or sensory disabilities that might prevent them from achieving full and active participation as others do in the society, on tackling different obstacles.



To put the convention terms into action, and out of human and ethical commitment towards the persons with disability in the Syrian society, who are marginalized and suffering from discrimination and low support rates, along with lack of rehabilitating programs, the organizers seek holding the second scientific conference "Towards Promotion, Integration and Empowerment Strategies in the Light of the UN 2030 Agenda for Sustainable Development".

The conference constitutes an important academic and humanitarian specialized activity concerning the affairs of persons with disability. There are different academic fields, centers and institutions of care and rehabilitation for persons with disability. The purpose of such facilities is: to draw the attention of scholars and experts in all scientific fields to that category of the society; to direct the humanitarian organizations towards offering more supportive programs for this broad category, especially in the Syrian society. 

Purposes of the Conference:

- 1: To present the results of the studies and researches submitted by scholars in the field of disability at times of crises and wars in special.
- 2: To attract applied scientific studies concerned with the accessibility of persons with disability and directing them to practical programs and actual products.
- 3: To Refer to the role played by educational institutions, especially universities, in addition to health and social foundations and organizations of the civil society, in supporting and advocating persons with disability.
- **4:** To present the international experiences in supporting, rehabilitating and integrating persons with disability.
- 5. To expose efforts of the organizations active in the field of disability, and discus the reality of the services offered to the persons with disability in Syria.
- 6: To study future plans for the purpose of advancing the reality of persons with disability to rehabilitate and integrate them educationally and professionally in the Syrian society.

Types of participations in the Conference:



First: Researches, work papers and initiatives

The conference accepts the refereed scientific researches and approves work papers and initiatives and reports and field applications integrated with the researches and studies submitted. The researchers can participate physically or online.



Second: Physical attendance only

Attendance of all parties interested in the affairs of persons with disability, with scientific, administrational and educational posts, and business market and media and social foundations and what alike are welcome. They are urged to enrich the discussion and the arguments, and exchange experiences, in addition to communicating with scientists and scholars and persons in-charge of the foundations.

The presence and participation of media foundations in covering the discussions and arguments in the lectures and the seminars are also welcome.

Participation Criteria:

There are different types of participation to be noted:

1.

First: Work paper:

It could take the form of ideas, dissertations, or programs with a quality addition. Such contributions are not required to meet scientific research terms. They could be submitted by activists in the field of disability, and by representatives of organizations and research centers as well.

2.

Second: Scientific research:

There are terms to be met:

- Participation is available to all professors, scholars and higher studies students (Ma & PhD).
- 2 The research should be original, not published before, and not submitted in other contexts. Submission is an implicit and clear acknowledgement on the part of the researcher to be accounted for.
- 3 Researches should go with the themes of the conference.
- An Abstract in Arabic should be presented, 500 words maximum with 5 key words. It should include the title of the research (Traditional Arabic size 16 wide), the full name of the researcher as it will be shown out in the certificate of the conference and official papers (size 14 wide), the institution he belongs to if any (size 14 wide), the abstract to be drafted with normal font, size 14, single line spacing. The research should be accompanied by a CV with a personal photo.

- Once received, the researchers will be informed by email.
- 6 Researches are to be subject to secret scientific arbitration. They will be evaluated in terms of: originality, depth, extent of contribution, and integrity of presentation and language.
- Acceptance of the contribution to be sent on receiving the abstracts, which are to be presented to the scientific committee. On receiving the research in full, it will be arbitrated. Notes of revision if any are to be sent and the researcher is committed to fulfilling the modifications required.
- 8 Work papers submitted by activists and representatives of organizations and research centers are to be approved regardless of meeting terms of scientific research.
- Arabic, Turkish and English are the languages accepted for presentation.
- 10 Participants will be granted a participation certificate issued by Aleppo University and the organizers, in addition to conference bag.
- Original researches to be published in refereed scientific journals with ISIN once met the terms of scientific publication.

Participation Fees:

No fees required.

Important Dates:

Deadline for abstract reception: 15-07-2023

Deadline for research and reports reception in full: 30-08-2023



Criteria of scientific researches and studies submission, after abstract approval:

- The cover page should includes: research title, full name of the researcher (s) in Arabic and English, employer, address, email and date of the research. The name of the research (s) should not be included in the body of the research, nor any reference that may uncover their identity. In case the researcher (s) tends to acknowledge and party that contributes or participates in the achievement of the work, they should be mentioned in an independent page.
- An abstract of no more than 200 words should be submitted in Arabic, and another one in English not exceeding 200 words, each in independent page. Each abstract should include title of the research, 5 key words in Arabic and English.

 Mentioning of names ore research data should be avoided.




- Research should not exceed 30 pages including references and figures with the exception of the appendixes.
- Types and fonts of drafting: A4 page, single spacing, margins (2.5 cm min.)

 including notes, references, quotes, tables and appendixes.
- **105** Typing Font:

Arabic: 14 traditional Arabic

English: 14 Times New Roman

- In case the researcher made use of any data collecting tool, a full version of it should be presented accompanying the publication request.
- **7** Researches sent should meet all scientific research requirements.
- Documentation of the references and resources to be indicated inside the research or in the references list, whether in Arabic or English, in addition to the quotations from web sites and pages or multiple information resources, or e-books, in accordance to the system of APA7 (American Psychological Association 7th edition).
